- 2. **Time**: 10.00 A.M. onwards.
- 3. **Venue**: North Eastern Council Secretariat, Nongrim Hills, Shillong 793003, Meghalaya.
- 4. Selection to the post of Senior Technical Assistant in the NEC Secretariat, Shillong is subject to fulfillment of the eligibility criteria as contained in the Notification of the examination as well as satisfactory completion of Document Verification and merely appearing the Document Verification does not guarantee selection/appointment to the post of Senior Technical Assistant or confer upon you any right for final appointment in NEC Secretariat, Shillong.
- 5. You are, therefore, requested to appear for the Document Verification on 01.04.2024 with this Call Letter/Instruction Manual (in original) along with the following documents as well as self-attested photocopies of the same:
